Informational Items and Discussion Points

Council on Clinical Affairs report

- The Council requested that the International Association of Dental Trauma's (IADT) guidelines on trauma management be proposed for endorsement by the General Assembly, rather than a revision of the current AAPD guideline; the Board approved.
- The Council will correct the Policy and Guideline on Xylitol so that both documents have the correct information; as a technical correction, this does not need approval by the General Assembly.
- The Council requested that the resource on Useful Medications for the Pediatric Practice be reviewed by a pharmacist; the Board approved; as a resource section document, this does not need approval by the General Assembly.
- The Board offered guidance for further revisions to the new Guideline on Passive Restraint.

Council on Scientific Affairs

• The Board had no revisions for the job description for Manager, Evidence-Based Dentistry; the job will be posted, to start no earlier than the end of annual session.

#### American Board of Pediatric Dentistry

• The ABPD requested that the AAPD look into creating a Board prep course, to cover such issues as how to take a standardized test.

Pediatric Oral Health Research and Policy Center

• The Policy Center has initiated talks with the Practice Based Research Network to create a regional component dedicated to children's oral health.

Request for comments from the ADA CDEL

- Dr. Berg received a letter just prior to the meeting from ADA Council on Dental Education and Licensure (attached), regarding the proposed separation of the CERP Committee from CDEL, for reasons having to do with dental licensure. Comments are requested by March 1.
- Dr. Berg requested that board members review the letter and forward comments to him by the end of February.

Request from AAO for support of proposal to CODA

- AAO would like to make participation in the MATCH program a requirement for accreditation and has requested a letter of support from AAPD.
- Some question of whether CODA has the authority to make such a requirement.

#### 2013 ADA Annual Session Pediatric Dental Program topic and speaker

• The Board agreed with the Executive Committee's recommendation of pulp therapy as the topic for the 2013 ADA Annual Session Pediatric Dental Program, and the selection of Dr. James Coll as speaker.

Dear Doctor Berg:

The Council on Dental Education and Licensure (CDEL) appreciates the American Academy of Pediatric Dentistry's support of quality continuing dental education through its participation in the ADA's Continuing Education Recognition Program (CERP). We would like to advise you of proposed changes to CERP that CDEL is considering, and request your feedback on the proposal described below.

As you know, CERP is currently administered by the CERP Committee, which is a standing committee of CDEL. The Committee is comprised of representatives of the nine recognized dental specialties, the American Association of Dental Boards, American Dental Education Association, American Society of Constituent Dental Executives, and the ADA. The CERP Committee reviews and approves providers of continuing dental education and makes recommendations to CDEL regarding program policies and recognition standards. These policies and standards must be approved by CDEL.

Under consideration is a proposal to separate CERP from CDEL, and reconfigure it as a new agency under the umbrella of the ADA. Oversight of the program would be conducted by a governing board comprised of representatives from the stakeholder groups. In addition to approving CE providers, the proposed new agency would have the authority to develop and approve recognition standards and program policies, thus minimizing potential conflicts of interest with other ADA agencies, programs and priorities. The CERP program would continue to be funded through provider fees and a subsidy from the ADA.

The decision to explore a new model was made after reviewing the organizational structures of other accrediting agencies in continuing education for the healthcare professions, analyzing CERP's current structure and CE environment, and assessing the advantages and disadvantages of several alternate models. CDEL will be evaluating whether the establishment of a new agency would enhance the program's reputation as an impartial, respected accrediting body and reflect best practices in continuing education.

CDEL will consider a detailed proposal at its April 2013 meeting. The Council would greatly appreciate any comments or questions that key stakeholders may have at this early stage. We invite you to provide your comments by March 1 so that they may be discussed at the Council's meeting in April. All communities of interest will have the opportunity to comment on the proposal again at a later date if CDEL recommends that it move forward.
