Editor-in-Chief Search Committee

In closed session, the board considered the recommendations of the Search Committee, interviewed finalists, determined on a candidate, and directed the President and Chief Executive Officer to negotiate terms.

Workforce Study

Informational

- Shortages are geographical rural areas, areas with smaller populations need pediatric dentists, large urban areas are over-saturated.
- Interesting finding was the state where a dentist got their High School education correlated with the state they currently practice in, more so than residency programs.
 AAPD (and ADA) could try to encourage recruitment from the areas where there are shortages.
- Findings will be published in a peer-reviewed journal.
- Next step is for the Policy Center to develop communication points based on the findings.

American Board of Pediatric Dentistry

Informational

Dr. Mabry provided some statistics on the Oral Clinical Exam (OCE) and the Qualifying Exam (QE).

- For the most recent OCE, there was an 86% pass rate; 470 new diplomates.
- Every year, the percentage of eligible dentists that are certified climbs 2-3%. Currently, 75% are certified.
- For the most recent QE, the pass rate was 95%.

Biennial Chapter Leadership Summit and PPA Workshop
